



Terms & Conditions

1. Registration fees: Only registered participants may take part in Fire-Walk. We cannot offer refunds if you are unable to take part.
2. Fundraising commitment: You aim to raise/set a target of £150 per person if you can. We understand raising sponsorship is not always easy and will support you the best we can. We reserve the right to remove your place if you have not demonstrated your intention and plan to reach your target. We cannot refund donations in the event of cancellation or if you are unable to take part.
3. Personal health: All participants attend this event at their own risk. As such, it is your responsibility to ensure that you are healthy enough to take part. If in doubt, please take advice from your medical practitioner. We strongly advise you to dress appropriately for the event – have warm and waterproof layers in case of bad weather – and sensible footwear you can easily slip on and off.
4. Personal safety and security: While the MND Scotland will take all reasonable steps to ensure the safety and security of participants, individuals take part at their own risk. During the event you are responsible for your own, and your team's, safety and responsibility. Furthermore, you agree to take reasonable care not to compromise other participants' safety and security.
5. Age limits: This event is not suitable for those under the age of 14. Those under 16 must have parental/guardian permission confirmed prior to registration. There is no maximum age limit but participants over 65 should seek advice from their medical practitioner.
6. Alcohol or drug consumption prior to the Fire-Walk is strictly prohibited. Anyone under the influence of alcohol or drugs will not be allowed to take part.
7. Animals: No animal or pet may be brought to the event without the prior consent of MND Scotland. If you have a registered help-dog please advise us prior to registering online.
8. Personal belongings: MND Scotland accepts no responsibility for loss or damage to your personal belongings during the event, including any items left in or outside the venue. We strongly advise you not to bring valuables or delicate technology.
